**RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH  
OF MARIETTA, LANCASTER COUNTY, PENNSYLVANIA,  
ESTABLISHING THE FEES TO BE IMPOSED FOR THE SUBMISSION,  
REVIEW, PROCESSING, ADMINISTRATION AND IMPLEMENTATION  
OF SUBDIVISION AND LAND DEVELOPMENT PLANS**

WHEREAS, Borough Council for the Borough of Marietta adopted the Borough's Subdivision and Land Development Ordinance at its public meeting on March 8, 2016; and

WHEREAS, Borough Council is permitted by law to levy reasonable fees for the review, processing, administration and implementation of subdivision and land development activities and plans within the Borough; and

WHEREAS, Borough Council desires to establish administrative fees, escrow fees, and procedures related to subdivision and land development activities in the Borough.

NOW THEREFORE, be it resolved by the Borough Council of the Borough of Marietta that the following fees and escrow structure for subdivision and land development activities and plans are established as follows:
