

Marietta Borough Council
Minutes of Reorganization Meeting held January 4, 2022
113 East Market Street, Marietta, PA

The organizational meeting of the Marietta Borough Council convened at 7:13 PM, Tuesday, January 4, 2022 in the Marietta Borough Council Chambers, 113 East Market Street, Marietta, PA 17547. In attendance were Council members Marsh, Mayor Carroll-Baltozer.

Mayor Carroll-Baltozer called the meeting to order.

Mayor Carroll-Baltozer swore in the new Council members, Jeffrey Hudson, Steven DeBottis, Miles Lauver III.

Council members took their seats. Mayor Carroll-Baltozer asked for nominations for Council President. Council member Marsh nominated Jeffrey Hudson as president. Nominations were closed and by acclamation Jeffrey Hudson is named President of Council.

President Hudson took over the meeting and asked for nominations for Council Vice-President. Council member Marsh nominated Freddy States as Vice-President. No other nominations. Nomination carries by unanimous vote that Freddy States is named Vice-President.

President Hudson asked for nominations for President Pro-tem. President Hudson nominated Jeffery Marsh as President Pro-tem. No other nomination carries by unanimous vote that Jeffery Marsh is named President Pro-tem.

President Hudson did not assign the appointments. He will speak with the new Council members and address this at the next Council meeting.

President Hudson asked for a motion for Resolution 01-2022. Council member Marsh made the motion to adopt Resolution 01-2022 Disposition of records, with a second by Council member Lauver. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 02-2022 to appoint Rick Thomas as the Vacancy Board chair for the Borough with a second by Council member Marsh. Motion carries unanimously by voice vote.

Council member Marsh made a motion to adopt Resolution 03-2022 to name Brandon Harter with the firm of Russell, Krafft, & Gruber law firm as Borough solicitor with a second by Council member DeBottis. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 04-2022 to appoint Michael Reiner with Sager, Swisher and Company as Borough auditor with a second by Council member Marsh. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 05-2022 to appoint Lynn Brumfield to the Housing Hearing Board with a second by Council member Lauver. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 06-2022 to appoint Ron Kistler as the Borough Zoning Officer/Deputy Code Enforcement Officer with a second by Council member Lauver. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 07-2022 to appoint Commonwealth Code Inspection Services as the Borough code official with a second by Council member Marsh. Motion carries unanimously by voice vote.

Council member Marsh made a motion to adopt Resolution 08-2022 to appoint Darrell Becker with ARRO Consulting as the Borough engineer with a second by Council member DeBottis. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 09-2022 to appoint William McMullen with ARRO Consulting as the Borough Sewage Enforcement Officer with a second by Council member Lauver. Motion carries unanimously by voice vote.

Council member Lauver made a motion to adopt Resolution 10-2022 to appoint Susquehanna Regional Police to service as the Borough Code Enforcement Officer with a second by Council member DeBottis. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 11-2022 to appoint Susquehanna Regional Police as the Animal Enforcement Officer for the Borough with a second by Council member Lauver. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 13-2022 to appoint Beverly Kreider to the Planning Commission with a second by Council member Marsh. Motion carries unanimously by voice vote.

Council member Lauver made a motion to adopt Resolution 14-2022 to appoint Charles Haugh as the Housing Officer with a second by Council member DeBottis. Motion carries unanimously by voice vote.

Council member DeBottis made a motion to adopt Resolution 15-2022 to appoint Frederick Gabriel II to the Zoning Hearing Board with a second by Council member Marsh. Motion carries unanimously by voice vote.

There being no further business to come before Council, on a motion by Council member Marsh with a second by Council member Lauver the meeting adjourned at 7:45 PM.
